1 Welcome From Phil

- 1.01 Phil welcomed congratulated group on good turnout for January and wished all a happy New Year

2 Treasurers Report

2.01 Richard advised the following bank account totals

- 2.01.6 Membership was believed to be between 145 and 150, with some resignations expected with 2019 membership due.
